#### Mass Mutual Important Loan Repayment Guidelines:

- Loan repayments will be due in equal monthly payments for the term of the loan.
- If your loans are current, you can only make one future payment in excess of your current payment due date. This is a requirement of the IRS where loan payments must be made no less than quarterly.
- Payments will be made through a debit ACH deduction from your bank account or via coupon book, which will be provided by MassMutual.
- You have the option to pay off the loan at any time.
- If the loan repayment is not made on time, the loan will go into default. Interest continues to accrue on defaulted loans for purposes of calculating outstanding loan balances. To avoid a loan default, you will have until the end of the quarter following the calendar quarter in which the loan repayment was not made in order to make the payment(s). Failure to make the repayment(s) will result in a deemed distribution from your account for the outstanding balance of the loan, which will be reported as taxable income.

# Reminder to all Journeymen ⇒

In our current contract - Section 2.19 Tool List - it states "In addition, Journeymen shall be responsible to have verifiable 'OSHA-10' training and CPR Certified Training." Please call the Training Center (315-546-0221) to see when the next scheduled classes are if you need either of these training sessions. OSHA-10 and CPR training are needed to work in Local 43's jurisdiction as a Journeyman.
